Raised over \$440,000, allowing 34 residents who had exhausted their resources to be provided charitable care!

Volunteers have increased from 45-56. The volunteers help with activities, visits, fundraising, and church services.



\$50,000 in grant funds were given towards a new 14-passenger wheelchair accessible van by the ELCA. The van is used by the whole campus for shopping, medical appointments, and scenic drives. Construction on the Arbor is on schedule to be done late 2025 or early 2026. When finished, it will provide 31 apartment units for seniors at a market rate. Apartments will include stacked washer/dryers, dishwasher, garbage disposal, walk-in showers, balconies or walk-out patios, carports, and storage closets. Residents can rest easy in the safety and security of our gated campus. They will have access to community rooms, a bbq patio, and a fitness room. They can take advantage of the campus amenities: bus service to shopping, an optional meal plan, maintenance support, and an after-hours manager. # Threads of Compassion: A Volunteer's Journey in Quilting & Sewing

Judy Edwards grew up in Wisconsin and graduated from the University of Wisconsin in La Crosse. In the summer of 1959, she worked in Seattle and took the Greyhound bus home. The bus stopped in Wallace for a dinner break, and when Judy stepped out into the cool air and piney smell of North Idaho she fell in love! She knew she would later want to live around there. In the meantime, her husband started working for Firestone and they started their own family. She worked as a computer programmer, which was groundbreaking for a woman during that time. She said that an aptitude test had sent her in that direction, and it turned out she was great at it and really enjoyed it! She worked for Intermountain Gas until her retirement.



Judy has lived in Coeur d'Alene for the last twenty years. She initially got involved with some women through the Coeur d'Alene Library and became a very active supporter. She was the President of Friends of the Library for twelve years, helped start and organize the used bookstore, and assisted with programs like the Lego Robotics involving students. She has also volunteered with the League of Women Voters. She helped with the Habitat for Humanity, sewing quilts for each new homeowner and putting on crew lunches for volunteers. She is involved with Our Daily Bread, a meal program at Lutheran Church of the Master that serves free hot meals every Sunday. She has enjoyed sewing skirts, pillowcase dresses, and washable sanitary napkins to include in Operation Christmas boxes through Christ the King Church. She also sews tote bags to be given to foster kids to carry their belongings instead of the trash bags that seem to be the norm. She also blesses Orchard Ridge Assisted Living and Memory Care with lap quilts to be used by residents. She loves being able to pull others around her into volunteer opportunities also!

Judy moved into Orchard Ridge Independent Living eight years ago. She waited an extra year on the waiting list to get the room she most desired, overlooking the trees and park-like atmosphere! She has served as President and Treasurer of the Resident Association. She was instrumental in starting the Meet & Greet time. She has pulled back some, letting newer residents take the lead.

She says that even though she is a loner by nature, living at Orchard Ridge provides her the opportunity to engage with others at times or pursue her hobbies alone in her room. She loves the beautiful campus and understanding staff. She enjoys the freedom of living independently, but in a safe and secure environment. The affordability was also a big factor in her decision to live at Orchard Ridge.



We are grateful to have Judy at Orchard Ridge and of the ways that she has enriched her community! It is amazing to think of her as a tiny, young girl watching her mother at the sewing machine and then seeing her skills used to bless so many people and organizations!
